Introduction

Rugged individualism and anti-government sentiment are a part of the fabric of Nevada. Equally woven into Nevada is the glitz and glamour of the gaming mecca, Las Vegas. There has always been a clash between Southern Nevada (Clark County) and the rest of Nevada. When looking at electoral politics, the clash is very evident.

During the 2022 election, Adam Laxalt stated, "Clark County? We got major problems down there. And we've got to fight that."¹ In a different speech, Laxalt said, "I do think votes count here. I do think votes count in at least 15 counties. Washoe County can be a little squirrelly."² Later in the year, election denier Laxalt was flanked by two Constitutional Sheriffs and Police Offices Assoc. (CSPOA) Sheriffs, Jesse Watts and Aitor Narvaiza, at a press conference.³

The CSPOA promotes the belief that Sheriffs are the true interpreters and enforcers of the constitution in their jurisdiction. However, legal authorities disagree. "They have no authority, not under their state constitutions or implementing statutes, to decide what's constitutional and what's not constitutional. That's what courts have the authority to do, not sheriffs," said Mary McCord, a former federal prosecutor and executive director of the Institute for Constitutional Advocacy and Protection at Georgetown University.⁴ McCord also stated that the CSPOA is part of

the "broader insurrectionist ideology that has gripped the nation since the 2020 presidential election."⁵

This paper will discuss the intersection of election denialism and the CSPOA in Nevada and how this may appear in the 2024 election and post-election. There is a lot at stake during the 2024 election. The cultural clash is being played out in modern politics, and the results will reverberate throughout the country for decades.

Constitutional Sheriffs and Peace Officers Association

Founded in 2011 by former Graham County, AZ sheriff Richard Mack, the Constitutional Sheriffs and Peace Officer Association has grown into a national organization that recruits sheriffs and law enforcement to the "patriot" movement.⁶ Identified as an anti-government organization by the Southern Poverty Law Center,⁷ Mack and CSPOA have close ties to the <u>Oath Keepers</u>, based in Las Vegas, NV.⁸ Mack was a former board member.⁹ He previously stated that "the greatest threat we face today is not terrorist; it is our own federal government."¹⁰

Mack has a long-standing relationship with anti-government activities in Nevada. In 2014, he was active in the <u>Bundy standoff</u> with the Oathkeepers and other militias when Cliven Bundy called for support against the federal government, which was coming to confiscate cattle grazing on federal lands.¹¹ Bundy refused to pay grazing fees to the Bureau of Land Management for the grazing rights.¹² The standoff between Bundy and his followers and the federal government lasted several weeks.

This anti-government sentiment is upfront in the CSPOA's organizing philosophy. Its ideology lies in the county supremacy and Posse Comitatus movements espoused by William Potter Gale in the 1970s.¹³ In short, the belief is that "the county, not the state or federal government, should control all land within its borders, and the county sheriff should be the ultimate law enforcement authority in the U.S." ¹⁴ In Nevada, where the federal government owns 85.9 percent of the land,¹⁵ it is easy to see how this idea, though flawed, took hold.

Article 6 of the Constitution states that local governments cannot override federal laws.¹⁶ However, in a 1997 case, *Printz v United States*, of which Mack was a petitioner

in the case, the Supreme Court of the United States ruled that the federal government cannot force counties to fulfill federal tasks, including disposing of handgun applications or notification of refusals.¹⁷ Mack and those in the county supremacy movement have expanded the ruling that the federal government cannot impose itself, which is opposed to Article 6. In a May 2020 interview, Mack stated, "Let me make this real clear: The president of the United States cannot tell your sheriff what to Do. I don't care if it's George Washington himself. They cannot tell us what to do."¹⁸ The CSPOA reached out to sheriffs and law enforcement through training, online videos, and books.¹⁹

Traditionally, the CSPOA has focused on issues regarding gun violence, immigration, and health policy.²¹ Constitutional Sheriffs have refused to enforce COVID-19 regulations and also common-sense gun regulations.²² In 2022, CSPOA partnered with the anti-immigration Peace Officers Association (PAN) and expanded their purview to investigate (<u>the now disproven</u>²³) allegations of election fraud in the 2020 election.²⁴ The two organizations also partnered with True the Vote, producers of the debunked 2000 Mules,²⁵ to further the call for election investigations.²⁶ Four Constitutional Sheriffs investigated and failed to substantiate election fraud allegations.²⁷

Not to be dissuaded, CSPOA has developed a plan to establish county supremacy and undermine the federal government.

The CSPOA 180-Day Plan

It is called the Florida Foundation for Freedom; however, in reality, it is a project by the CSPOA designed to interfere with the upcoming elections. The CSPOA 180-day plan would replace the federalist system of government with the "Bill of Rights Constitutional Sanctuary Counties."2829 The purpose of the plan is "through Constitutional Law, reestablish our Constitutional Republic and nullify all unconstitutional actus, including executive orders, legislation, proclamations, rules, regulations, statutes, supreme court decisions, treaties, and other acts that have been systematically used to usurp our God-given [sic] constitutional rights."³⁰ The plan describes the role of "Constitutional Sanctuary Counties" as follows:

"In passing this type of ordinance or resolution, the county government seeks to stop the unconstitutional circumvention of the legislative process and to nullify all acts, administrative orders, executive orders, judiciary rulings, legislative actions, mandates, proclamations, regulations, rules, statutes, and treaties which violates or unreasonably restricts, impedes, or impinges upon an individual's constitutional rights and violates the fundamental American doctrine of separation of powers. In doing so, the county declares such 'unlawful acts' to be invalid in that county and that they shall not be recognized by that county, and they shall be considered null and void of law and of no effect in that county."31

The CSPOA plans to direct the county sheriffs, commissioners, and election officials by issuing "Notifications of Specific Actions."³² If the Notification of Specific Actions is not implemented, the CSPOA threatens the removal of duly elected officials.³³ This removal is not by ballot but by using "citizen grand juries" or posses.³⁴

[&]quot;And this is one of the things that we're also working on is the concept of the citizen's grand jury. Because when you're not having a judiciary that's responsive to the Constitution, how do you deal with that? How do you basically hold the judiciary accountable? And a lot of the different legislative pieces that are being put forward to institute citizens grand juries that have that kind of teeth and say, listen, if you are a prosecutor, if you have had something brought to you that shows the evidence that there should be a grand jury impaneled and that the grand jury has given you the indictment that you must prosecute or you're going to be removed from office and there will be another person hired to do your job at the county's expense."

These posses or "citizen grand juries" would be citizen groups that agree with the CSPOA extreme right-wing interpretation of the Constitution and would conduct extrajudicial action to enforce compliance with the "Notifications of Specific Actions," including nullifying elections and removing duly-elected representatives on the State and County level.

The CSPOA 180-plan builds on and operationalizes the self-published work of Matt Trewhella.³⁵ Trewhella's work justifies a Christian nationalist revolution starting from the municipal and county levels.³⁶ Trewhella has advocated for the use of political violence, including the murder of abortion doctors and also the execution of LGBTQ+ individuals.³⁷

Constitutional Sheriffs in Nevada

From the Sagebrush Rebellion³⁸ to the Bundy Ranch standoff,³⁹ Nevada has a long tradition of anti-government sentiment and action. Between the military, the Bureau of Land Management (BLM), and the US Department of Forestry, the federal government controls most of Nevada's lands. Most Nevada ranchers lease grazing

This means the BLM regulates how many cattle ranchers utilize the land.⁴⁰ Land management and grazing fees were the basis of many government confrontations. So, it is understandable in Nevada's rural counties, the ideas of the CSPOA have taken root. The support of CSPOA by rural law enforcement is evidenced by their

attendance at the social gatherings to celebrate Lander County becoming the first

county to be a member of the organization in May 2021.⁴¹ Elko followed and is also a lifetime member of the CSPOA in June 2021.⁴²

Nevada has three known CSPOA sheriffs: Lander County Sheriff Ron Unger, Elko County Sheriff Aitor Narvaiza, and Eureka County Sheriff Jesse Watts. Sheriff Narvaiza and Watts were also active in the Protect America Now movement and filmed videos supporting the organization.⁴³ Sheriff Watts illustrated his county supremacy views in his letter to Governor Sisolak regarding Watts' refusal to enforce "red flag" laws in Eureka County.

Another Sheriff appears to align with the CSPOA but has not been officially identified as a member. Douglas County Sheriff Dan Coverly attended the same Laxalt campaign as Watts and Aitor.⁴⁴ The Nevada State Ethics Commission fined Sheriff Coverly for attending the event in uniform. Coverly was a fellow at the Claremont Institute, as well.⁴⁵ The institute's mission "is to restore the principles of the American Founding to their rightful preeminent authority in our national life."⁴⁶

Election Denialism in CSPOA Counties

This section will highlight social listening from county officials with a CSPOA or a CSPOA-aligned Sheriff and Washoe County, which has a history of election denialism on the Board of County Commissioners. 

Risk of the 2024 Election

Refusal to Certify

Based on the actions of past elections, it is expected that at least one or more of the counties will refuse to certify the election in an attempt to disrupt the Presidential election process with the continued claims of voter fraud. Under the Electoral Count Reform Act, Nevada must certify the state's presidential electors by December 11, 2024.⁴⁸ A county's delay in certification can cause a risk for Nevada to meet the deadline.⁴⁹ The unfortunate reality is that if Nevada fails to certify our presidential electors, Nevada will forfeit its six electoral votes, and the number of electoral votes needed nationally will be reduced by six. In short, by playing the games with the certification, elected officials risk nullifying all our votes.

However, there are guardrails in place to prevent this from happening. First, counties must complete the election canvass by November 15 and submit their certification to the Secretary of State.⁵⁰ If a county refuses to certify, the Secretary of State and Attorney General can petition the Nevada Supreme Court for a writ of mandamus.⁵¹ This procedure was implemented during the 2024 primary election when

Washoe County refused to certify the election.⁵² The Nevada Supreme Court had the opportunity to resolve this issue permanently. However, they dismissed the case as moot when Washoe County reconsidered the vote, and the certification passed.^{53 54}If a county still refuses to follow the writ of mandamus, the Nevada Supreme Court can order an alternative official to certify the election.

Policing at Poll Sites

With the increase of threats against election officials and election workers,⁵⁵ it is foreseeable that law enforcement may monitor poll locations.⁵⁶ In 2022, True the Vote, Protect America Now, and the CSPOA joined together to provide "local sheriffs with the information, resources, and tools to have real-time eyes on voting in their county," which is beyond the scope of most county sheriffs' duty.⁵⁷ And this year, Constitutional Sheriffs attempted to organize citizen patrols at polling locations to prevent non-citizen voting.⁵⁸ It is not a stretch of the imagination to believe that CSPOA and CSPOA-aligned sheriffs, with the support of their county commissions, will attempt to have law enforcement monitor polls.

While there are some legitimate reasons for law enforcement to be at the polls, their presence should only be noticeable to voters if election officials call them.⁵⁹ Otherwise, their presence may be intimidating to marginalized citizens with the right to vote.

Conclusion

The CSPOA is a genuine threat to our democracy and our elections. Three Nevada counties have already achieved two prongs of the CSPOA 180-day plan to usurp our state and federal elections and governments. The three counties where the

CSPOA sheriffs operate have commissions stacked with election deniers. While several guardrails are in place to ensure the 2024 election will be certified, it will most likely be with some unnecessary obstacles by the CSPOA counties.

Recommendations:

- Increase civics education requirements in Nevada schools. K-12 civics education will help increase the understanding of government and the election process, thus helping to inoculate against disinformation and anti-government sentiment.
- Improve outreach by the Secretary of State's Election Department to local communities. Ideally, this should be in collaboration with the election department. This would allow community members to understand the election process better and increase confidence that the process is secure.
- Improve legislation regarding voter safety. During the 2023 Legislation session, AB354 was introduced, which would have prohibited firearms from being carried or possessed within 100 feet of an election site. This bill passed both houses and was subsequently vetoed. It is recommended that similar legislation be enacted to increase the safety of voters.
- The Nevada Secretary of State and local election departments should review and update their election office procedures to meet current best practices. Since most counties have new election officials, all incoming election officials must have clear guidance on administering an election. To help quell the growing mistrust of elections, election departments and the Nevada Secretary of State's office should engage in public input/engagement meetings to discuss and explain the procedures to communities throughout Nevada.
- Currently, there is no legislation regarding mandatory recounts in close elections. As such, Nevada should pass standardized legislation/regulations establishing a threshold at which a mandatory recount would be generated. The governing election department should pay for the mandatory recount. If a candidate wishes to ask for a recount outside the required threshold, the candidate must pay for the recount. The cost should be affordable and accessible to all candidates.
